

Data Policy of Cel Blau Apartments

Data Collection

Data Usage

- 2.2. We do not share your personal data with third parties unless necessary for the provision of services related to Cel Blau Apartments or when legally obligated to do so.

Cookies and Tracking Technologies

- 3.1. We use cookies and similar technologies on our website to collect information about your site usage and enhance your experience. You can configure your cookie preferences through your browser settings. Please refer to our Cookie Policy for more information.

Data Security

- 4.1. We implement appropriate technical and organizational security measures to protect your personal data against unauthorized access, disclosure, or misuse.
- 4.2. We retain your personal data only for as long as necessary to fulfill the purposes for which it was collected unless there is a legal or regulatory obligation requiring its retention for a longer period.

Your Rights

- 5.1. We respect your rights regarding your personal data and provide you with the means to exercise them. You can request access, rectification, erasure, or restriction of processing of your personal data. You can also object to the processing of your personal data or request its portability.
